3. One visa application form completed and signed.
4. Two 2" x 2" passport size photographs.
5. One completed and signed work history form.
6. Copy of flight itinerary from Asia Transpacific Journeys.
7. Non US citizens submit valid I-94 or a copy of your Alien Registration Card *aka Green Card*.
