IMPORTANT VISA INFORMATION

Dear Traveler,

To assist you in preparing for your upcoming tour with Odysseys Unlimited: *Treasures of Jordan* with the post-tour option to *Istanbul, Turkey*, we would like to advise you that both Jordan and Turkey require a visa for entry.

If you wish, you may obtain your visas easily upon arrival in Turkey (at the Istanbul airport). This is a quick and simple process that costs approximately \$30US per person in Turkey. We recommend that you have exact change and use clean, crisp bills.

You may also obtain your visa upon arrival in Jordan (at the Amman airport). This costs approximately 20 Jordanian dinar (JOD) per person (approximately \$29 US). This must be paid in the local currency, which also can be obtained upon arrival. Please note, if there are five or more Odysseys Unlimited guests arriving and departing on the same flights, an Odysseys representative will obtain a visa for the group on a complimentary basis.

Or, you may obtain your visa in advance through a visa service. Please note that this does entail a substantial processing fee. Should you wish to obtain your visa in advance, included below are visa application forms and an instruction sheets for G3 Visas & Passports, the visa service we recommend.

You may also obtain your visa through a visa service of your choice or directly through the embassy of the country (or countries) you plan to visit. Should you choose to apply for your visa directly through an embassy or a different visa service, you must contact the embassy or visa service directly to obtain the proper forms and applications. The enclosed forms are valid for G3 Visas & Passports only.

To obtain your visa in advance, you must apply for your visa 45 to 60 days prior to your departure from the U.S. If you apply sooner, your visa may expire before the completion of your tour.

Please note that the visa application form must be filled out by each person traveling.

However you choose to obtain your visa, please note that your passport should be valid for at least six months following your tour, and that it should have at least 3 to 5 blank pages available, as you may be denied entry should these pages be unavailable.

These instructions are for U.S. citizens only. If you are not a U.S. citizen, please contact your embassy or a visa service for information about the documents required for your tour.

Please send the following to G3 Visas & Passports:

1. **Your original valid and signed passport**. The passport must have at least two blank pages marked "Visas" and must be valid for a least 6 months past the end of your trip.
2. Non-US citizens must include a copy of their Alien Registration card or US visa and original I-94.
3. One TURKEY visa application form, completed and signed (see attached).
4. One JORDAN visa application form, completed and signed (see attached).
5. Two passport style photographs (2"x2"), taken within the last 6 months. The photos must be on photo paper and have a plain white background. Attach photos with a paper clip; do not use tape or glue.
6. Proof of departure: i.e. copy of your computer-generated flight itinerary from Odysseys Unlimited.
7. This cover sheet with all fields completed; only one cover sheet is required per family.

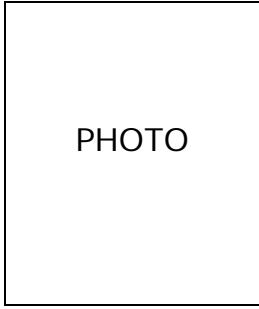
